**AGREEMENT**

In consideration of the City's issuance of the permit, I, as owner/contractor responsible for the work, do hereby agree as follows:

1. That all work will be done in conformity with applicable law and regulations, specifically the provisions of Defiance Code, Chapter 1020, and the regulations of the City Engineering Division. This work will include marking the work area to protect pedestrians and the traveling public, until the time backfill, repair of pavement, sidewalk and lawn areas are complete.
2. That all work, as indicated above, will be performed in the time provided, and in conformity with lawful conditions included in the permit to protect the public health, safety and welfare.
3. That I, as owner/contractor responsible for the work, hereby agree to indemnify the City of Defiance, Ohio, for all damage to its property, and hold the City harmless from all claims suits, losses, and expenses it may incur to persons not a party to this Agreement arising out of the activities of the applicant, his agent, employees, or contractors, in connection with a permit issued on the basis of this application.
4. That this Agreement shall not be construed as a limitation of the authority of the City Administrator to revoke this permit because of the applicant's, or his agent's or contractor's failure to comply with state and local laws, regulations or conditions in this permit, or any other lawful basis or revocation.
5. That the statements made in this application are true and correct, to the best of my knowledge.

If the inspector responds to a request and finds the project is not ready for an inspection, there will be a **\$5.00 reinspection fee charged and added to the permit fee.**
