

Dear Ladies and Gentlemen:

This yearly report is a summarization of the Defiance Police Departments policing activities for the year 2023. Our staffing for 2023 stood at 31 sworn officers consisting of twenty-one Patrol Officers, four Sergeants, three Lieutenants, Assistant Chief of Police, and Chief of Police. The Police Division also consists of two civilian Clerks and one Administrative Secretary. During the course of 2023, one new officer was hired. Ptl. Samuel Neely was sworn in as a Patrol Officer in June of 2023 to fill the vacancy created by Ptl. Robert Orta resigning from the Defiance Police Department as a full time police officer.

The officers of the police department were very busy and active throughout 2023. The Defiance Police Division handled 19,956 calls for service in 2023. This equates to an average of 55 calls for service per day. Providing quality services to our community is the driving force to the mission of our department. I believe that we accomplished that mission through the dedicated service of each member of our department. The dedication to service of the officers and staff of the Defiance Police Department is to be commended. In 2023, fourteen additional body cameras were purchased for the officers of the police department ensuring that all road patrol officers have their own camera assigned to them. The body cameras continue to be a great asset in ensuring that the police division is delivering quality service to the community and citizens of the City of Defiance.

The Defiance Police Department continues to provide the services of two full time School Resource Officers. The SRO program continues to evolve and strengthen the community relationship with our police department. K-9 Mojo continues to be a valuable tool for SRO Herbert. Mojo remains certified in tracking, drug and explosives detection. Mojo's addition has greatly increased the ability of our SRO program to ensure the safety and welfare of our schools, staff, and students. Mojo has been used on several occasions for drug detection and explosive detection during routine and emergency sweeps of the schools in the City of Defiance.


The Defiance Police Department continues to provide K-9 Units to increase the capabilities and effectiveness of the Defiance Police Department. Ptl. Garrett Roth and his K-9 Myrko continue to serve as the K-9 unit for the City of Defiance. In 2023, Ptl. Tristan Sanders and K-9 Kenzo were added to the Defiance Police Department's K9 unit. Both K-9 units continue to assist the surrounding agencies and communities in providing additional police support.

We also continue serving as a member of the Multi Area Narcotics Task Force. One officer is assigned to full time duties fighting illegal drug activity in the City of Defiance, and the other member jurisdictions. Emphasis continues to be placed on programming that fosters a strong police and citizen relationship in the City of Defiance.

Coffee with a Cop continues to provide a great platform for building police community relations. I look forward to the continued vitality of this program. The Police Department Facebook page has been a great success in reaching the community. This has proven to be a great asset for sharing information with the public, and for solving crimes. Since the implementation of the Facebook page there have been scam and fraud alerts, safety tips, and community events shared with the public. This continues platform aiding with the return of lost property, and the solving of several crimes through tips provided by the public. The Facebook page has also strengthened our connection to the community, and has proved itself a valuable resource.

Officers and staff of the Defiance Police Department are dedicated in continuing to provide the quality services the citizens of Defiance expect from our division. We have a diverse group of officers and we will continue to move the department in a positive direction and provide our city with the best law enforcement possible. The officers of the Defiance Police Department once again look forward to working with the City Administration, City Council, and the citizens of Defiance to continue to make Defiance, "A great place to live". We would like to thank the community for the opportunity to serve, and encourage all to stop in anytime. Our doors are always open.

## Detective Bureau – 2023 Year End Summary

The year 2023 saw the effects of staffing challenges. Some additional assistance was received by officers who were temporarily out of normal work status. Low levels of Road Patrol staffing resulted in Detectives being removed from the DB to work Road Patrol. Thank you to the many officers who worked together to complete necessary tasks and investigations to ensure that our service to the community was maintained.

We continued to work with many area agencies to collaboratively bring the best possible service to the Defiance community. These agencies include: Probation Departments, Adult Parole Authority, City of Defiance Law Department, Defiance County Prosecutor's Office, Victim Advocates, Ravens Care, Red Cross, SART Clinic, Job & Family Services, Child Abuse Task Force, other law enforcement agencies, local fire departments, church organizations and other support agencies. Our combined resources and willingness of employees from every agency to work together for the citizens of our community is what provides the best tools for victims, reasonable legal outcomes, and prosecution. By allowing agencies that have employees who specialize in a specific area to take a role in the reported incidents, we can assure that our community is receiving treatment and care within mandated and existing guidelines.

Crimes being committed in the Defiance area range from crimes of opportunity, which may involve one-time offenders, all the way to organized crime networks, often found involved in burglaries and larger thefts. We understand that working with regional enforcement agencies, FBI, and Task Forces are beneficial for long-term investigations that are multi-jurisdictional, sometimes involving different states. We maintain contact with local area agencies through internet access and being members of the Area Law Enforcement Investigators Association (ALEIA) covering Ohio, Indiana, and Michigan. We continue working with and meeting with local law enforcement agencies on local crime trends and investigations that are commonly crossing jurisdictional boundaries or the suspects are committing crimes in multiple jurisdictions.

We operate within the guidelines of the Memorandum of Understandings (MOU's) that are set in place by management. One MOU is with the State Fire Marshall's Office, and another is with the Defiance College (DC). The State Fire Marshall's Office assumes lead for fire investigations while we provide necessary support and assistance. The MOU with DC is utilized to help promote positive police interactions with faculty and students while allowing necessary

investigative processes to take place while respecting the rights and privacy of everyone involved.

The Detective Bureau is responsible for being the liaison for the Defiance Police Department to the Defiance County Prosecutor's Office and consists of a Detective Sergeant, Detective Patrolman, and PD Clerks. The Clerks maintain compliance with the mandates for evidence logging of sexual assault cases, coordinate information transfers, obtain legal documents, and transcribe statements when needed. All felony charges for the PD flow through the DB, even though many Road Patrol Officers do complete felony cases. All felony cases are openly discussed with the Prosecutor's Office in a "Grand Jury Review" process. This provides needed time to review cases, make decisions on further investigatory actions, and to determine the best course of action through the criminal prosecution process. The DB also participates in meetings with the Prosecutor that are held with a victim and Victim Advocate to help facilitate the harmonious relationship between the agencies to provide the best support system to a victim throughout the time of pending cases.

Property Room Technicians are responsible for maintaining the orderly operation of our Property Room, staying in contact with BCI Laboratory for submission of property for analysis, the return of analyzed property, and obtaining analysis results and distribution of the results to investigating officers. It's a necessity to manage the release of Body Worn Camera and In-Car Recording System footage to the Prosecutors as needed for all cases. The DB is responsible for transporting the evidence to BCI for processing. In 2023, lab submission sheets were received from officers requesting evidence processing that totaled 70 pieces of evidence from 58 cases. The Multi-Area Narcotics Unit continues to house equipment to provide certified testing of drugs, which reduces turn-a-round time for lab results. Two addition officers from the PD have been certified to operate this machine. A majority of the drug evidence is now tested at the MAN Unit, which consisted of 45 items from 40 different cases.

The DB is responsible for providing support to Road Patrol. We share investigative experience and techniques with officers to assist them in developing their investigative abilities. Conversations occur on a daily basis between Road Patrol and Detectives to share case information, develop investigative strategies for cases, and to share investigative technique information. A large amount of time and effort is being put into investigations involving the collection of electronic evidence, methods required to obtain this evidence from numerous companies involved in the digital world, and gaining an understanding of the various apps being used by the public on various social media platforms. The DB often assists with investigations by processing scenes, conducting follow-up interviews, drafting search warrants, and tracking down leads that may cross jurisdictional boundaries. Some cases may require the DB to take it over, while others only require some form of assistance. We

recognize that it is the combination of the DB and Road Patrol working together that produces the most positive outcomes. The DB investigated a total of 180 cases. The DB directly receives some complaints. Seventy-three of the cases were referred by the Road Patrol for the DB to complete. In addition, there were 60 more cases that requested DB assistance. The DB was involved in a total of 240 cases which resulted in numerous files being sent for Prosecutor Review for charge considerations. Often, the cases are presented by the DB to the Grand Jury.


Below is a chart of complaint statistics in which the cases were assigned to the DB. The cases indicate if arrests were made, but do not indicate the number of persons charged in the case, if the charged person was adult or juvenile, nor the number of charges filed on each person. The case could still be an open investigation.

All felony cases flow through the DB because of necessary contact with the Prosecutor's Office and case reviews. The chart below shows the case summary for Indictments. In some cases where the DB assists, charges are filed by Road Patrol. The total Indictments include charges directly filed by the DB and those filed by Road Patrol. Being adult or juvenile is not specified. Indictments included: Felonious Assault, TPO Violation, Menacing by Stalking, Gross Sexual Imposition, Agg. Possession of Drugs Agg., Failure to Comply, Thefts, Improperly Handling of Firearm, OVI, Weapons Under Disability, Receiving Stolen Property, Abduction, Domestic Violence, Tampering with Evidence, Child Endangering, Rape, B&E, Vandalism, Pandering Obscenity Involving a Minor, Pandering Sexually - Oriented Matter Involving Minor, Intimidation, Disseminating Matter Harmful to Juveniles, Burglary, Vandalism, Domestic Violence, Aggravated Riot, Kidnapping, Unlawful Sexual Conduct with a Minor, Corrupting Another with Drugs, Identity Fraud, Misuse of Credit Cards, Possession Drugs (Meth/Cocaine/Fentanyl), Robbery/Agg. Robbery, Disrupting Public Services, Engaging in Pattern of Corrupt Activity, Importuning, Sexual Battery, Theft from Person in Protected Case, Tampering with Records, Compelling Prostitution, Agg. The age ranges for these schools are ages 3 - 22. The following is a list of some of the activities and duties I am involved in or complete pertaining to the schools and students.

- Conduct risk assessments for schools both interior and exterior.
- Outside of normal school hours I participate in Shop with a Cop, security for afterschool activities, and participate in school activities such as homecoming parade and K-9 demonstrations.

As a school resource officer, I am given the unique opportunity to sit and listen to students to help them feel heard, which is very important. I also get to participate in school activities with them. This allows the children to see law enforcement in a positive atmosphere. This position has been rewarding as well as challenging. It allows me to work with many agencies and resources when assisting children with their school career and home environment.

The training is extensive, up-to-date, relative, and constant to my position as SRO and a patrolman. Some examples of my training are a 40-hour SRO Certification, news articles, in-person training, and online training. I also stay update on current news events when it pertains school safety. ## Defiance Police Department School Resource Officer Year End Report

Chief Shafer,

The year 2023 concluded my 2nd year as the Defiance High/Middle School's resource officer. Overall, the students have been great. The biggest ongoing issue is vaping. Myself, in conjunction with the school staff have implemented ways to combat this problem. Vape detectors have been installed in most of the bathrooms, however the problem is where the students are hiding their devices. Most are now hiding the vapes on their person and we are looking at ways to attempt to find these. Due to my rapport with a lot of the students, acts of violence in the form of fights have been prevented due to a student reporting a problem between students before it becomes violent.

My daily activities include a variety of issues involving students. Harassments, Sex Offenses, Assaults, Disorderly Conducts, Truancy and Drugs are the most common. Along with these, I also routinely check exterior and interior doors to ensure they are locked to ensure safety and monitor the lunches and hallways. In conjunction with HS staff, we routinely check the parking lots.

I continue to work closely with the District Office, High School staff and Middle School staff. We keep what is best for the student populace first and foremost when making decisions on what needs to be done. Our mutual respect allows our relationship between the Defiance City Police Department and the Defiance City Schools to flourish. After working together over the past two years, we are starting to get an understanding of where each other stands when it comes to certain issues. Staff and myself are both comfortable enough with each other to be honest even when it might not be what the other wants to hear.

My K9 Partner Mojo has been paramount in building relationships with the students of Defiance High and Middle Schools. Just having her with me continues to be an ice breaker between the students and myself. The schools, on occasion have also allowed a few students to assist me in Mojo's training by laying tracks for me. Mojo routinely assists in checking lockers, cars and backpacks at the schools and has located 9 THC Vape devices. Her presence in the schools will be even more relevant with the legalization of Marijuana in Ohio. There has already been an uptick of students being under the influence of THC, so far it has primarily been by way of a Cart or THC Gummies. K9 Mojo has also assisted the MAN Unit on

search warrants and assisted them in the locating of narcotics. Her presence at other events, like career days has made it so that students from other school districts recognize her as well.

A way to further connect with students of DHS and DMS, I have continued to run what was formerly known as the Explorers and is now called the Cadets. After our first full year in operation, we have seen an increase in participation, with over 40 students from Defiance City, Ayersville, Hicksville, Fairview, Bryan, and Findlay. The first Cadet Camp was held in 2023 at Camp Lakota. The experience was enjoyed by all.

My role as an SRO has allowed me to assist students get through some of their tough times. Around 60 percent of my job is counseling students about their home life or their life in general. Many times there is an issue with a student contemplating suicide or self-harm. I along with the guidance counselors are often the ones who engage with the student and assure they are getting the help they need.


Due to the nature of the position of SRO, I continue to work well with other agencies from around the county. I have worked closely with the Juvenile Prosecutor's Office, Juvenile Probation and Jobs and Family Services. These relationships have been mutually beneficial to all. Due to our level of respect for each other, we have been able to continue to do what is best for the juvenile population in Defiance.

This year I have attended 19 hours of SRO related training. This includes the SRO Conference and Ohio School Threat Assessment Training and Autism Awareness. Aside from these trainings I have also attended additional LE classes throughout the year, totaling 306.42 hours.

I have a good working relationship with the staff at Defiance Middle/High Schools. My relationship with the staff is one of mutual respect and understanding. We work well together and have been able to work together due to a common goal of doing what is best for the individual student and the rest of the student body. It remains my goal to be a role model for the students of DHS/DMS and to continue to build a rapport with those students.

I have tracked my activity utilizing the approved daily log sheet, in accordance with the DPD Policy.



To whom it may concern,

The year 2023 was a very productive year for the Defiance Police Department and the Multi-Area Narcotics Task Force. The Defiance Agent assigned to the MAN Unit is consistently and historically leading the charge in combating illegal narcotics use and sale in the City of Defiance, and surrounding counties.

During the course of the year, the MAN Unit handled over 344 cases. The Defiance Police Department Agent handled 110 cases where he was primary, and had 40 involvements in other Agents' cases. For Defiance City/County Agents, in Defiance County handled over 39 search warrants which include residences, cell phones, and trash pulls. We also had approximately 97 felony drug indictments for Defiance County. These indictments included over 34 Felony 2 Drug trafficking charges and four Felony 1 trafficking Charges. The Defiance City MAN UNIT Agent has also handled several cases with Felony 1 indictments in both Paulding and Putnam counties that involved both methamphetamine and the sale of fentanyl pills. These were being brought into the City of Defiance to be sold and used. Special emphasis has been placed on interdicting fentanyl over the past year resulting in a significantly lower number of fatal overdose deaths in the City of Defiance and Defiance County compared to previous years. Overall, we are proud to serve the Defiance City Area and are attempting to make the City of Defiance a better place to live and have a drug free environment for our residents.
