Dear Ladies and Gentlemen:

This yearly report is a summarization of the Defiance Police Departments policing activities for the year 2024. Our staffing for 2024 stood at 31 sworn officers consisting of twenty-one Patrol Officers, four Sergeants, three Lieutenants, Assistant Chief of Police, and Chief of Police. The Police Division also consists of two civilian Clerks and one Administrative Secretary. During the course of 2024, two new officers were hired. Ptl. James Michael Aden was sworn in on 07/17/2024 as a Patrol Officer to replace Sgt. George Moser who retired after twenty-five years of service. Ptl. Savannah McCoy was hired on 07/29/2024 to fill the vacancy created by Ptl. Mark Janowiecki resigning from the Defiance Police Department as a full time police officer.

The officers of the police department were very busy and active throughout 2024. The Defiance Police Division handled 19,046 calls for service in 2024. This equates to an average of 52 calls for service per day. Providing quality services to our community is the driving force to the mission of our department. I believe that we accomplished that mission through the dedicated service of each member of our department. The dedication to service of the officers and staff of the Defiance Police Department is to be commended.

The Defiance Police Department continues to provide the services of two full time School Resource Officers. Ptl. Frank Herbert continued as the High School and Middle School SRO. Ptl. Adam Kunz started as the Elementary School SRO in the fall, replacing Ptl. Janowiecki after he resigned as a full time officer. SRO Kunz has acclimated very well to the new position. The SRO program continues to evolve and strengthen the community relationship with our police department. K-9 Mojo continues to be a valuable tool for SRO Herbert. Mojo remains certified in tracking, drug and explosives detection. Mojo's addition has greatly increased the ability of our SRO program to ensure the safety and welfare of our schools, staff, and students. Mojo has been used on several occasions for drug detection and explosive detection during routine and emergency sweeps of the schools in the City of Defiance.

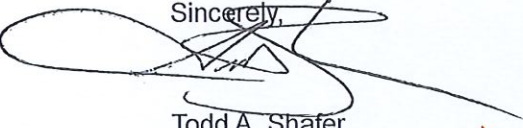
The Defiance Police Department continues to provide K-9 Units to increase the capabilities and effectiveness of the Defiance Police Department. Ptl. Garrett Roth and his K-9 Myrko, and Ptl. Tristan Sanders and K-9 Kenzo continue to serve as the K-9 units for the Defiance Police Division. Both K-9 units continue to assist the surrounding agencies and communities in providing additional police support.

The Defiance Police Department also continues serving as a member of the Multi Area Narcotics Task Force. One officer is currently assigned to full time duties as a drug agent fighting illegal drug activity in the City of Defiance, and the other member jurisdictions. Our commitment to the MAN Unit remains vital to ensuring wellbeing and safety of our community and the citizens of the City of Defiance.

Emphasis continues to be placed on programming that fosters a strong police and citizen relationship in the City of Defiance. Coffee with a Cop continues to provide a great platform for building police community relations. I look forward to the continued vitality of this program. The Police Department Facebook page has been a great success in reaching the community. This has proven to be a great asset for sharing information with the public, and for solving crimes. Since the implementation of the Facebook page there have been scam and fraud alerts, safety tips, and community events shared with the public, and aids with the return of lost property, and the solving of several crimes through tips provided by the public. The Facebook page has also strengthened our connection to the community, and has proved itself a valuable resource.

Officers and staff of the Defiance Police Department are dedicated in continuing to provide the quality services the citizens of Defiance expect from our division. We have a diverse group of officers and we will continue to move the department in a positive direction and provide our city with the best law enforcement possible. The officers of the Defiance Police Department once again look forward to working with the City Administration, City Council, and the citizens of Defiance to continue to make Defiance, "A great place to live". We would like to thank the community for the opportunity to serve, and encourage all to stop in anytime. Our doors are always open.

Detective Bureau Year End Report

In 2024, Sexual Assault cases went up where 2023 saw 50 investigations with 11 arrests and in 2024, we had 70 cases investigated with 23 arrests. We continued to see B&E reports where drugs were a factor. Although the Multi Area Narcotics Task Force handles the majority of drug investigations, those who use these drugs continue to commit crimes such as shoplifting, burglaries, and thefts to pay for their addictions.

In all, the Detective Bureau handled 136 investigations, while continuing to assist the patrol division and the prosecutor's office with follow up requests. We also provide assistance to the Defiance County Job and Family Services, the MAN Unit, Defiance County Juvenile Probation, Defiance Fire and Rescue, as well as the Defiance County Sheriffs' Office. The Police Department continues its MOU with the State Fire Marshalls office requesting that they take the lead on Cause and Origin investigations on all suspicious fires. The breakdown of Detective Bureau investigations is as follows:

Sex Offense: 70 reports with 23 cleared by arrest, 14 under investigation, 3 forwarded to another agency  
Robbery/Burglary/B&E/Prowler: 4 reports with 0 cleared by arrest  
Theft/Fraud: 13 reports with 5 cleared by arrest  
Fire/Arson: 2 reports with 0 cleared by arrest  
Miscellaneous: 14 reports with no arrests  
Abuse: 15 reports with 5 cleared by arrest, 2 investigations are still open  
Death Investigations: 7 reports with 2 cleared by arrest and 2 under investigation  
Harassment/Threat/Assault: 10 reports with 8 cleared by arrest  
Assist / Warrants: 10  
Stolen Vehicle: 2 reports with 0 cleared by arrest  
Drugs: 4 reports with 2 cleared by arrest

The Detective Bureau works hard to develop and build on relationships with investigators in Northwest Ohio. We had participated in the Area Law Enforcement Investigators Association (ALEIA) where we meet with investigators from Northwest Ohio, South East Michigan, and the Toledo area on a quarterly basis. Although this group no longer exists, the investigator for the Defiance County Sheriffs Office, Mike Shock, has put together a group for Northwest Ohio where we continue to meet locally in the absence of a more regionalized group.

The Detective Bureau continues to work with our partnerships with other non-Law Enforcement Agencies such as the Better Business Bureau (BBB), Child Protective Services, Senior protective Services, Ravens Care/Red Cross, and SART Clinic of Northwest Ohio. The BBB continues to be of assistance in determining fraudulent activity in the area as well as getting information to the public about the frauds that are in our area. Child Protective Services provides needed assistance and information in cases of child abuse, child sexual assault and neglect investigations. Adult protective services is a function of the Defiance Paulding Consolidated Job and Family Services agency and they have recently dedicated a full time social worker to address the needs of the adult community for ages 60 and over. Some of the services provided by this program are heating, food, evictions, and our agency works closely with them for guardianship needs/fraudulent activity/abuse and/or



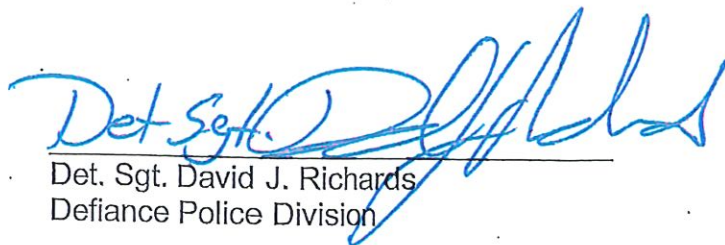
neglect to ensure that they are able to safely stay in their homes. Ravens Care and the Red Cross will provide housing and other emergency aid when the need arises. Ravens Care acts as a clearing house for church donations to provide for families who are in crisis while the Red Cross responds to a call for help when a family goes through an unforeseen disaster such as a house fire. The SART Clinic was designed for the privacy of the sexual assault victim and is in its own space where the victim does not have to worry about seeing someone they know while going through this process. The SART Clinic has proven to be an invaluable tool in fighting crime as they continue to see ways to further assist in this effort. The SART Clinic has offered its services to the victims of Domestic Violence where they can document injuries with the latest technology in digital imagery as well as trained nurses who can identify injuries that an officer may not see or recognize.

The Victim Assistance program offered through Sarah's House also helps in this process. Victim Advocates are the gateway to the SART Clinic as they will activate the SART procedures allowing the officer/investigator to continue working the case while valuable evidence is being collected and documented by a trained forensic Nurse Examiner. The Victim assistance program also aids in our mission to connect citizens with valuable resources when necessary. In addition to providing a safe space for victim interviews, we refer families to mental health partners, domestic violence shelters, and other resources to meet their individual needs.

A good example of how these multijurisdictional relationships aid in investigations is this case where a woman reported to the Mercy Police Department that her juvenile sister found a hidden camera in the bathroom of their home. An investigation by the Defiance Police Department, with the assistance of the Multi Area Narcotics Unit, Defiance County Job and Family Services, Defiance County Prosecutor's Office, Defiance County Victim's Assistance/SARAH's House, and the Toledo Police Department Forensic Lab, led to the discovery of the camera and the arrest of the mother's live-in boyfriend, Aaron Tatkowski. He was ultimately convicted of four counts of pandering obscenities involving a minor and sentenced to 22 ½ years in prison.

We continue to participate in Law Enforcement based groups that deal with Child Abuse and Felony crimes such as the Child Abuse Taskforce, Grand Jury Review, and SART Clinic quarterly meetings. The Taskforce meets monthly and is comprised of investigators from Defiance County S.O., Hicksville PD, Defiance County Prosecutors Office, and the Defiance/Paulding Consolidated Job and Family Services where we discuss our cases to ensure that they are being handled in a fair and consistent manner throughout Defiance County. Grand Jury review is between the Detective Bureau and the Defiance County Prosecutors Office where we discuss all Felony level crimes to determine the best course of action for each case. This allows for input from different levels of the process to voice the concerns and risks involved with prosecuting, or not prosecuting a specific case. These relationships and co-operations are vital to the success of the Detective Bureau as it continues to find ways to better serve the citizens of Defiance.

As the Detective Sergeant, I am accountable for all evidence that enters the Departments Evidence Room. The Evidence Room is maintained by one of the department's clerks and another Sergeant who actively manage all incoming and outgoing items. The Detective Bureau also makes multiple trips each month to the State Crime Lab, Bureau of Criminal Investigations, in Bowling Green, Ohio.

## **End-of-Year Report: School Resource Officer**

**Overview:** This report summarizes the activities, achievements, and challenges faced by the School Resource Officer (SRO) during the 2024 Calander Year at Defiance High School and Defiance Middle School. The focus has been on fostering a safe and supportive learning environment while prioritizing student counseling and engagement.

### **1. Key Responsibilities:**

- **Safety and Security:** Ensuring a secure campus through regular patrols, emergency preparedness drills, and addressing safety concerns.
- **Counseling and Mentorship:** Providing support to students through one-on-one counseling sessions, crisis intervention, and guiding students toward positive decision-making.
- **Education and Outreach:** Teaching topics such as substance abuse, sexting awareness and online safety.
- **Collaboration:** Working closely with school administration, teachers, counselors, and parents to support student well-being.

### **2. Counseling Initiatives:**

#### **2.1. One-on-One Student Counseling:**

- Total Sessions Conducted: 116
- Common Issues Addressed:
  - Bullying (in-person and online)
  - Family-related stress and trauma
  - Peer conflicts
  - Academic pressure
  - Substance use concerns
  - Military aspirations
  - Dating relationships

#### **2.2. Group Counseling and Workshops:**

- Organized 4 group sessions covering conflict resolution.
- Collaborated with school counselors to provide tailored support for at-risk students.
- Assist in running the Drug Free Leadership Council

### **2.3. Crisis Intervention:**

- Responded to 15 incidents requiring immediate intervention, including mental health crises and conflict de-escalation.
- Facilitated referrals to external resources, such as mental health professionals and social services.

### **3. Educational and Preventative Efforts:**

- Hosted interactive sessions to build trust and rapport with students.
- Participated in school events such as assemblies and fun days.

### **4. Achievements:**

- Enhanced student trust in law enforcement through consistent, approachable interactions.
- Contributed to a measurable reduction in reported bullying incidents
- Supported at-risk students, resulting in improved attendance and conflict resolution.

### **5. Challenges:**

- Increasing demand for mental health support exceeded available resources.
- Balancing the dual role of law enforcement and counselor required constant adaptability.



- Addressing the evolving nature of digital threats, such as cyberbullying and inappropriate social media usage.

## 6. Goals for the Next Academic Year:


- Expand group counseling programs to reach a broader student population.
- Strengthen partnerships with local mental health organizations to provide enhanced support.
- Increase preventative measures by developing more comprehensive workshops and resources.
- Focus on professional development to improve crisis intervention skills.

School Resource Officer Year End Report**

Chief Shafer,

In August 2024, I began my role as the new School Resource Officer at Defiance Elementary School, St. John Lutheran School, Holy Cross, and Good Sam. The transition from August to December went smoothly. The first few weeks were dedicated to becoming familiar with the school, its staff, and students. My primary focus during this period was on becoming a visible and approachable figure for both students and staff, ensuring they knew who I was and felt comfortable reaching out if needed.

One of my first challenges was the ongoing parking issues. Parents frequently drove through the grass, bypassing the designated parking lines to access the parking lot. To address this safety concern, I worked with the school administration and maintenance to implement a rope barrier along the grassy areas, clearly marking the spaces where vehicles were not allowed to drive. This simple solution helped maintain safety in the parking lot during pickup and drop-off times, reducing the risk of accidents and ensuring both parents and students could follow a smoother process.

Another challenge that arose early on was dealing with truancy issues. Several students were frequently absent, which caused concern both for their education and for their safety. As the SRO I worked closely with the attendance Secretary, Deb Randall, and K-5 Counselor, Mr. Beck, to track attendance and set up meetings with parents when necessary. Additionally, cases of parental neglect required intervention, often involving collaboration with JFS to ensure that the well-being of the students was prioritized and that the necessary actions taken to support them.

Despite the smooth transition in many areas, I faced challenges with students who exhibited more extreme behavioral issues. A few students with mental health and behavioral challenges presented ongoing difficulties, but I made it a point to work closely with the staff to address these issues in the school setting. As the weeks progressed, I noticed an increase in physical altercations on the playground, mostly involving 4<sup>th</sup> and 5<sup>th</sup> grade students. Instead of escalating situations into criminal matters, I worked with the staff to discipline the students appropriately within the school, focusing on conflict resolution and accountability.



My role as SRO also included conducting regular exterior and interior door checks. I consistently monitored both the interior and exterior of the school to make sure that all doors were locked and secure, and that there were no potential threats. These regular security checks allowed me to address any vulnerabilities immediately, reinforcing the vigilance in keeping the school safe.

By the time December arrived, the school had undergone a positive transformation. The parking lot issues had been largely resolved with the new barrier, truancy rates had begun to improve with proactive communication with parents, and the school's security measures were stronger than ever. I have established strong working relationships with the staff, and together we tackled challenges while ensuring the school environment remained welcoming, safe, and conducive to learning. The first few months of the school year set the foundation for what I hope will continue to be a successful and supportive role at Defiance Elementary School for years to come. I have tracked my activity utilizing the approved daily log, in accordance with the DPD Policy.

K-9 Myrko has been a part of the Defiance Police Department for 8 years now. It's been a successful year and we are proud to report our accomplishments throughout 2024. Here is a report of our activity within the past year.

Myrko and I assisted the following agencies in 2024:

- MAN Unit
- Defiance County Sheriff's Office
- Ohio Adult Parole Authority
- Defiance County Adult Probation

Part of being a K9 handler is about engaging with the public. These public relations duties include K9 demonstrations, business walk throughs, narcotics sweeps, school lock down drills etc.

-On 02/15/24, I assisted Defiance High School with a lockdown drill. K9 Myrko, along with multiple other police dogs, were utilized to conduct a sweep of the lockers.

-On 06/08/24, I conducted a K9 demonstration at the Northtowne Mall. This demo was for Family Fun Day which was organized by Maurice's.

-On 09/18/24, I had the opportunity to conduct a K9 demonstration for the seventh year in a row for the First Baptist Church Awana program. Children in the audience ranged from preschool to seniors in high school.

-On 10/30/24, I conducted a K9 demo at Active Day (formerly Person Centered Services)

Police dogs are a wonderful asset to police departments all over the world. They are a great tool to have in preventing serious injuries to officers, preventing incidents from escalating further, and are a strong deterrent for criminal activity.

In 2024, Myrko had a total of 16 K9 jobs. Myrko and I have been partners since 2017 and graduated K9 academy on 6/23/17. Our first official day on the road together as a fully certified K9 team was on 6/26/17. I have compiled a progress report from 6/26/17 to the present to show the impact Myrko has had on this department.

In Total Myrko has compiled:

- 135 total arrests.
- 86 misdemeanor arrests
- 49 felony arrests
- Approximately 123 grams of Methamphetamine
- 36 grams Cocaine

K-9 Kenzo completed his first full year at the Defiance Police Department as of 12-17-24. He was utilized approximately 86 times and had a very successful first year on duty. Below is a brief summary of our activity during 2024.

K-9 Kenzo and I assisted the Defiance County Sheriff's Office and the Ohio State Highway Patrol with vehicle walk arounds. K-9 Kenzo was deployed for an approximate total of 53 times.

During 11 stops, narcotics were located 11 times after K-9 Kenzo alerted on the vehicle. The largest amount recovered was 73.2 grams of methamphetamine. Another stop included meth, shrooms, and cocaine following an alert. An additional 15 stops that K-9 Kenzo alerted on were search with no contraband found, however, occupants admitted to using hard drugs in the vehicle recently, or have a history of drug use. K-9 Kenzo did not alert on a vehicle 23 times.

K-9 Kenzo conducted 13 building searches after open doors were located during afterhours business checks.

K-9 Kenzo was utilized for 7 tracks including 1 burglary, 2 stolen vehicles, 1 suicide, and 3 suspicious person complaints. At least 4 of the tracks were successful and found to be accurate after further investigation.

K-9 Kenzo performed several demonstrations for children and adults of all ages while showing off his skills regarding drugs, tracking, obedience, and aggression.

Various other tasks were performed such as school lock downs, article searches, and aggression for subject control. We also attend monthly trainings in Allen County, Indiana to keep K-9 Kenzo's skills sharp and up to date.

K-9 Kenzo continues to perform exceedingly well and passed his annual certification with no issues. We look forward to an even better 2025.

To whom it may concern,

2024 was a very productive year for the Defiance Police Department and the Multi-Area Narcotics Task Force. The Defiance Agent assigned to the MAN Unit is consistently and historically leading the charge in combating illegal narcotics use and sale in the City of Defiance, and surrounding counties.

During the course of the year, the MAN Unit handled over 345 cases. The Defiance Police Department Agent handled 87 cases where he was primary and had over 40 involvements in other Agents cases. For Defiance City/County Agents in Defiance County handled over 37 search warrants which include residences, vehicles, cell phones, and trash pulls. We also had approximately 67 felony drug indictments for Defiance County. The Defiance City MAN UNIT Agent has also handled several cases with Felony 1 indictments in both Defiance and Henry counties that involved both methamphetamine and the sale of fentanyl pills that were being brought up to the City of Defiance to be sold and used. One specific case, led to the arrest of a major Fentanyl supplier in Detroit, Michigan. Special emphasis has been placed on interdicting fentanyl over the past two years resulting in a significantly lower number of fatal overdose deaths in the City of Defiance and Defiance County compared to other counties in the state of Ohio. Overall we are proud to serve the Defiance City Area and are attempting to make the City of Defiance a better place to live in and have a drug free environment for our residents.
