The Project includes the following Work: Improvements to the existing Screening and Grit Removal Building, including replacement of the existing screening equipment with two center flow fine screens, each with a capacity of approximately 14 million gallons per day, and associated screening channel, sluice gate, and building structural, mechanical, and electrical upgrades. Additionally, the Project includes the installation of a new septage receiving facility immediately adjacent to the existing wastewater treatment plant site, including associated site civil, structural, mechanical, plumbing, and electrical improvements.

CONTRACTOR shall pay wages to each laborer and mechanic at a rate not less than the higher of the minimum wages specified in the current wage determination in accordance with the provisions of the Davis-Bacon Act and by the State of Ohio Department of Commerce.

Bidders shall comply with Presidential Executive Order No. 11246, Equal Employment Opportunity as amended.

Bidders attention is called to the fact that any Contract awarded under this Advertisement to Bid is expected to be funded in part by funds from the Ohio Environmental Protection Agency Water Pollution Loan Fund. All iron and steel products used on the Project shall be produced in the United States and comply with the American Iron and Steel Requirements.

OWNER reserves the right to reject any or all Bids, to waive any technicality, and to accept any Bid which it deems advantageous. All Bids shall remain subject to acceptance for 110 days after the time set for receiving Bids.

Contract award shall be made based on the lowest responsive and responsible Bidder.
