**In addition to the information furnished by your answers to the questions on the preceding pages, the application will not be deemed complete and the 10 day review period will not begin until you have provided the following supplemental documentation:**

- 1. A copy of the registrations for all vehicles identified on page 1.**
- 2. Proof of compliance with the minimum financial responsibility requirements of Ohio Revised Code Chapter 4509 with respect to each vehicle identified on Page 1.**
- 3. A copy of the driver's license of each person authorized to operate the vehicles identified on Page 1.**
- 4. Two (2)-Two inch square photographs, clearly and accurately showing the applicant's facial features. The photograph will be included in the photo identification permit to be issued upon approval of the application. If there are multiple solicitors, each must have his or her individual license.**
- 5. Proof of identity in the form of a fingerprint identification collected under the supervision of the Police Division. The Chief of Police has designated the Defiance County Sheriff's Office as the law enforcement agency to collect the required fingerprint exemplars. These are done at the Defiance County Courthouse located at 221 Clinton Street Defiance, Ohio 43512. Please have the results mailed to: 324 Perry Street Defiance, Ohio 43512 and the reason code is "Solicitor's License". The Sheriff's Office charges a fee for this service.**
